# 3. Paddock and Recreation Ground

#### i. To receive an update

Cllr Ripley reported that the safety inspections have been carried out. The right leg post of the air walker is loose, it seems to be an ongoing issue and although not urgent could become more difficult if the dry weather persists. Cllr Denny has reported that the grassed area in the paddock which was again raised will be ok and can be reviewed in November after the summer *ACTION: Cllr Berntsen to contact the maintenance contractor which dealt with the same problem earlier.*

Cllr Lewin said the suggestions from the school need to be looked at in detail, some items require changes. It is good to see the enthusiastic response from the school, they have made some very good suggestions.

#### iii. To consider quotations for litter bins

Cllr Ripley said the Council is still waiting to get price from Swale Borough Council.

# 4. Allotments

Cllr Ripley said a plot has been relinquished and people on waiting list are being contacted. Cllr Bodycomb said he will arrange to meet a prospective plot holder.

# 5. Burial Ground and Churchyard

Cllr Ripley reported that he has removed the broken bench, the new memorial bench is being delivered to the contractor for installation.

Cllr Lewin said there needs to be a liaison meeting with the Parochial Church Council regarding the churchyard ashes area and the responsibility of that. Someone has asked about the maintenance of the rose garden.

Cllr Ripley said the Council agreed that Upchurch Parish Council's Burial ground Policy that the maintenance of the Memorial Roses are the responsibility of the family or friends to tend.
